ORDINANCE 2009-13

**AN ORDINANCE OF THE TOWNSHIP OF MANSFIELD, COUNTY OF
BURLINGTON AND STATE OF NEW JERSEY AMENDING CHAPTER 60-11,
SECTION A, OF THE CODE OF THE TOWNSHIP OF MANSFIELD BY MODIFYING
THE SPEED LIMIT ON DESIGNATED ROADS WITHIN THE TOWNSHIP OF
MANSFIELD, THE CORRECTION OF ROAD NAME AND THE
REPEALING OF CERTAIN ROAD LOCATION AND SPEED DESIGNATION**

BE IT ORDAINED AND ENACTED by the Township Committee of the Township of Mansfield, County of Burlington and State of New Jersey as follows:

WHEREAS, the governing body has determined that the speed of traffic on a certain road and street within the Township has to be regulated in order to ensure the safety of pedestrians in the motoring public; and

WHEREAS, N.J.S.A 39:4-8 authorizes action by the governing body to alter speed limitations and designate limits of speed on certain roads and streets; and

WHEREAS, it is deemed to be in the public good and to enhance public safety and the general welfare by establishing speed limits on designated roads and streets within the Township.

NOW THEREFORE BE IT ORDAINED AND ESTABLISHED by the Committee of the Township of Mansfield, in the County of Burlington and State of New Jersey, as follows:

Chapter 60 of the Code of the Township of Mansfield is hereby amended by adding thereto to Section 60-11, Section A the following:

60-11. Speed limit on Island Road (Zone 1) between the Springfield-Mansfield boundary line and Mount Pleasant Road (County 543) is hereby restricted to 40 mph

Chapter 60 of the Code of the Township of Mansfield is hereby amended by correcting thereto to Section 60-11, Section A the following::

60-11. Correcting of road name throughout the entire section A from Mansfield-Georgetown Road to be now known as Mansfield Road East.

Chapter 60 of the Code of the Township of Mansfield is hereby amended by deleting therefrom of Section 60-11, Section A the following:

60-11 Repealing designated name of road, speed limit and road location, indicated under Ordinance 1994-13, amended on August 10, 1994, referencing North Island Road, location White Pine Road to Mount Pleasant Road which was designated with a speed limit of 35 mph.

REPEALER, SEVERABILITY AND EFFECTIVE DATE.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
