A discussion on field use by baseball and softball teams during the late summer and fall season was brought up regarding field use fees for outside organizations. In the past, we have not charged teams for practice time on the fields during these off season months when the fields are not being maintained by the township. The teams are working the

fields for their practices. Colleen Herbert brought up the point that it is a safety issue if the fields are being used and that we need to have them maintained for the outside teams that are being approved for park permits and if they are being maintained by the township then there the field use fees should apply to all outside groups.

2. Jersey Outlaws '03: use of softball fields at MCP and Civic Club field for games and practices; use of indoor facility for practices from 8/15/15 to 8/15/16. Insurance is through 1/1/2016 and will need to provide new insurance certificate in December for 2016. Field use and indoor facility is subject to availability around rec teams and subject to usage fees. 3. Northern Burlington HS Football Booster Club: park permit for bonfire in area to the left of the concessions stand on Friday September 25, 2015. The committee had a discussion regarding a potential conflict with a previous approved permit for the same area in the park (CHAS fall fair was approved for Sunday Sept. 27, 2015). The remnants of the bonfire would have to be cleaned up on Saturday and with the High School's Homecoming game that day it was questionable if the field could be cleaned up that day. The committee suggested the Booster club use another area of the park or inquire with the other townships.

A motion to not recommend the approval of the park permit for that field (to the left of the concession stand) on that date (Sept 25th, 2015) due to prior approval of CHAS's park permit was made by Brian Sisz and second by Randy Feig. Colleen Herbert voted no, and all remaining members voted yes and the motion passed. The members of the rec committee are okay with use of 9 acres area near the park exit provided the township and fire department are okay with that location. The rec committee also recommends that the booster club should have the area cleaned up within 48 hours or there should be a \$1000.00 fine for clean up by the township.
