The regular meeting of the Mansfield Township Board of Health was held on the above shown date with the following in attendance: **Mayor Arthur Puglia, Deputy Mayor Robert Higgins, Committeeman Alfred Clark, Committeeman Sean Gable, Committeewoman Janice DiGiuseppe, Attorney Michael Magee, Board of Health Secretary Linda Semus and Deputy Clerk Barbara Crammer.**

**Mayor Puglia** called the meeting to order at 7:30PM followed by the following opening statement:

**WRITTEN REPORT: Landfill Inspection Report: (8-15-12, 9-6-12)**

Mr. John Kampo was in attendance and explained that Jef Jones had contacted him about the trucks getting flat tires. There was also a complaint about the mulch. He said there was a lot of mulch and, when the trucks leave the dumping area, they start to slide. That particular cell is now finished. They are into the new cell. Eventually they will take all the cells and put them together and there will be one huge road. Mr. Kampo then explained that, when trucks are leaving the dumping site, they pull out a bit and then shake the truck, leaving garbage on the roadway. When trucks then go into the landfill, they run over garbage. They add a lot of mulch which creates sliding of the trucks. Jef Jones felt they are ruining the truck. Mr. Kampo advised him to speak to Mike who he felt would cooperate.
