**RESOLUTION 2010-5-1**

**RATIFYING AND CERTIFYING THE MANSFIELD TOWNSHIP SCHOOL DISTRICT  
2011-2012 BUDGET**

**WHEREAS**, the proposed budget for Current Expenses and the proposed budget for Capital Expenditures for the fiscal year 2011-2012 of the Mansfield Township School district was rejected by the voters of the District at the annual school election held on April 27, 2011; and

**WHEREAS**, the Township Committee of the Township of Mansfield has had discussions with the Mansfield Township Board of Education to discuss said budget and potential reductions; and

**WHEREAS**, pursuant to N.J.S.A. 18A:22-37, the Township Committee, after consultation with the Mansfield Township School District, has determined, in its judgment, the amount which is necessary to be appropriated to provide a thorough and efficient system of schools in the Township of Mansfield; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Mansfield, County of Burlington, and State of New Jersey that, in accordance with provisions of N.J.S.A. 18A:22-37, the following amount is determined to be necessary to be raised to provide a thorough and efficient system of schools in the Mansfield Township School District:
