RESOLUTION 2011-9-4

**AN EMERGENCY RESOLUTION IN ACCORDANCE
WITH N.J.S.A. 40A:4-48 AUTHORIZING EMERGENCY
APPROPRIATIONS DURING ANY CALENDAR YEAR
WHEN CURRENT APPROPRIATIONS WERE NOT SUFFICIENT**

WHEREAS, an emergency has arisen with respect to Hurricane Irene Declared Emergency and no adequate provision was made in the 2011 budget for the aforesaid purpose, and N.J.S. 40A:4-46 provides for the creation of an emergency appropriation for the purpose mentioned above, and;

WHEREAS, the total amount of the emergency appropriations created, including the appropriation to be created by this resolution is \$ 17,100 and three (3) percent of the total operating appropriations in the budget for 2011 is \$198,034.54; and

WHEREAS, the foregoing appropriation together with prior appropriation does not exceed three (3) percent of the total current fund operating appropriations in the budget for 2011.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee, Township of Mansfield, County of Burlington, State of New Jersey (by not less than 2/3 of all governing body members affirmatively concurring) that in accordance with N.J.S. 40A:4-48:

1. An emergency appropriation is here by made for the purpose of providing sufficient cash to fund those expenses related to the Hurricane Irene Declared Emergency in the amount of \$ 1,200 for Salary and Wages and \$ 15,800 for Other Expenses for a total of \$ 17,000.
2. That said emergency appropriation shall be provided for in full in the 2012 budget, and is requested to be excluded from CAPS, pursuant to N.J.S. 40A:4-53.3c(1).
3. That two (2) certified copies of this resolution be filed with the Director of the Division of Local Government Services
