Facilities: Colleen Herbert showed the committee the plans for the new building at the Civic Club location that will have a concessions room, storage and bathrooms. Colleen is looking to have the lights in the bathroom be automatic to avoid the problem that we have in the park when the doors lock for the night and the light was left on. The building will be set up like the other rec buildings with keycard access. Rob Siverio questioned the safety in the parking lots with having to go through the parking lot from the fields. The Township Committee approved the High School bonfire request at the 9 acres area in MCP but questioned why it was not being done at the High School. The Committee will be discussing this with the High School admins.
The Township Committee approved Northern's proposal to eliminate the building use fees for the recreation programs. LaVerne asked if the school will give priority to any outside organizations that will pay the usage fees.
