

**MANSFIELD TOWNSHIP

BOARD OF HEALTH
December 27, 2012**

The regular meeting of the Mansfield Township Board of Health was held on the above shown date with the following in attendance: **Mayor Arthur Puglia, Deputy Mayor Robert Higgins, Committeeman Alfred Clark, Committeewoman Janice DiGiuseppe, Attorney Michael Magee, Board of Health Secretary Linda Semus and Deputy Clerk Barbara Crammer. Committeeman Gable** was not in attendance.

Mayor Puglia called the meeting to order at 7:30PM followed by the following opening statement:

Rabies Clinic Program for 2013

Clerk Semus explained that the rabies clinic would be held as it was last year. There will be no licenses issued. It will be strictly for inoculations. The state has notified us that, beginning January of 2013, they are not sponsoring the rabies clinic program any more. There will be extra charges this year although they will provide the serum. She will contact them to determine how much it will cost the Township. Any cost can be taken from the trust fund.

The cats are then released to the area where they have been picked up but they cannot reproduce. After brief discussion, she was told to find out the cost for the program. This will be reported at the January meeting.


PUBLIC COMMENT
