RESOLUTION 2015-5-13

**A RESOLUTION MEMORIALIZING THE AUTHORIZATION OF THE TOWNSHIP OF MANSFIELD
TO ENTER INTO AN AGREEMENT WITH A PLUS TECHNOLOGY, A NATIONAL COOP, TO
PROVIDE AND INSTALL CAMERAS AT GEORGETOWN PARK**

WHEREAS, Mansfield Township has received a grant from Burlington County's Municipal Park Development Program in the amount of \$159,000, with the grant for the cameras being \$ 33,728.00; and

WHEREAS, Mansfield Township is desirous of installing cameras at Georgetown Park; and

WHEREAS, Mansfield Township has been working on purchasing the cameras for Georgetown Park through a National Coop, which is offered through the State Division Purchase & Property, which eliminates the formal bidding process; and

WHEREAS, A Plus Technology has submitted a quote in the amount of \$ 29,877.99 which includes all equipment and installation which excludes any electrical costs associated with electrical lines being installed to the stadium pole that will house three cameras; and

WHEREAS, pursuant to Resolution 2015-5-12, a contract to Flynn's Electric was awarded in the amount of \$3,000.00; and

WHEREAS, any additional costs that may be associated with this project can utilize the remaining funds appropriated, in the amount of \$850.01; and

WHEREAS, at the completion of said project, all funds remaining will be re-appropriated for the Hedding Park portion of the grant funding awarded; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Mansfield, County of Burlington, and State of New Jersey at their regular meeting held on April 22, 2015, at the Municipal Complex at 7:30 PM that:

1. Memorialize the action taken at the April 8, 2015 Township Committee meeting for a contract award with A Plus Technology provide and install cameras at Georgetown Park, for a sum not to exceed \$29,877.99. This includes all equipment and installation.
2. This award is made available through the following account:
