RESOLUTION AUTHORIZING THE SUBMISSION OF REVISED APPLICATION FOR THE PROGRAM YEAR 2015 BURLINGTON COUNTY COMMUNITY DEVELOPMENT GRANT AS ADMINISTERED BY THE BURLINGTON COUNTY DEPARTMENT OF ECONOMIC DEVELOPMENT

WHEREAS, Mansfield Township has prepared an application for the 2015 Burlington County Community Development Block Grant as a funding request for Phase III to continue ADA Accessible Doorways and path of travel to the second floor, front entrance of the Municipal building, as well as, connecting existing accessible paths along the parking lot at the Municipal Complex (Millennium Building), at 3135 Route 206, Columbus, NJ, which said improvements are to assist in ADA regulations; and

WHEREAS, this application was approved and accepted by the Township Committee; and

WHEREAS, it is understood that the scope of work stated above exceed the program's funding amount. The amount listed in the project cost estimate represents the total project cost. The Township is not prepared to supplement CDBG funding with other funding sources; and

WHEREAS, this resolution represents a revised application requesting that the CDBG Grant be used to provide an accessible route to the second floor. Proposing to utilize the existing elevator and create an opening in existing masonry wall on second floor to provide total access to all occupied and vacant space on second floor.

WHEREAS, this revised application must have Mayor and Township Committee approval.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Township Committee for the Township of Mansfield, County of Burlington, New Jersey, fully supports and approves this revised grant funding request to the Burlington County Community Development Block Grant Program, which does not require any local matching funds.

BE IT FURTHER RESOLVED that the Mansfield Township Committee will conduct a hearing at its regular town meeting on January 27, 2016 at 7:30 pm for residents to comment during that public portion of the hearing.
