**New Business:**

2. *Dumping on Axe Factory Road-* still happening and one idea is to have cameras installed. Bob Tallon also said he will look into the cost and possibility of putting signs out in the area where the dumping occurs the most.
3. *Environmental Commission in Chesterfield (environmental fair?)* The Commission is in favor of possibly working with Chesterfield for an environmental fair. No information at this time but everyone is open to the idea.

4. *Updating environmental inventory:* should be updated, especially in regards to the storm basins. The township needs to know who is responsible for them and are they being taken care of properly. It is important that they are working well to keep the streams clean. Bob suggested a checklist for identifying who owns the land and /or who is responsible for maintaining the basins. Another suggestion was to reach out to ANJEC and ask if they would look at the inventory to see if there is anything we should be adding anything.

Bob updated the Commission on the condition of the watershed.
