Mike Fitzpatrick requested a meeting with Bob Tallon, Jeff Jones, Bob Higgins regarding the Stormwater Utilites.

Bob Tallon advised the Board that stormwater basins have building standards but there is nothing in place to monitor what happens after, what flows into the basins.

Township owns 16 basins, and developers in the area own other ones.

It is strongly recommended that the Township should consider joining the Stormwater Utilities. There will be a fee for each basin, but an inspection and report will be provided which will insure that they work properly and are within the guidelines created by the State.
